## Tommy Bahama Hawaii Sweepstakes Official Rules

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

<u>Overview</u>: The Tommy Bahama Hawaii Sweepstakes (the "Sweepstakes") consists of two (2) types of Sweepstakes drawings, a grand prize drawing (the "Grand Prize Drawing") and multiple first prize drawings (each a "First Prize Drawing"). There are one hundred (100) Tommy Bahama retail stores/restaurants (as applicable) (each a "Participating Tommy Bahama Store") participating in this promotion, one (1) First Prize Drawing will be performed for each Participating Tommy Bahama Store where one (1) First Prize will be awarded for each Participating Tommy Bahama Store. See **Appendix A** for complete list of Participating Tommy Bahama Stores. See Section 5 and 6 below for complete Grand Prize and First Prize Drawing and Prize details.

- 1. Eligibility: The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Tommy Bahama Group, Inc. ("Sponsor"), Merkle Inc. ("Administrator"), and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules. Sponsor's and Administrator's decisions are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- **2. Sponsor:** Tommy Bahama Group, Inc., 400 Fairview Ave North, Suite 488, Seattle, WA 98109. **Administrator**: Merkle Inc., 3000 Town Center, Suite 2100, Southfield, MI 48075.
- **3. Timing:** The Sweepstakes begins on March 24, 2023 at 12:00 a.m. Eastern Time ("ET") and ends on April 24, 2023 at 11:59 p.m. ET (the "Promotion Period"). Administrator's computer is the official time-keeping device for the Sweepstakes.
- **4. How to Enter:** There are two (2) ways to enter the Sweepstakes:
  - a. In-Store Method of Entry: During the Promotion Period, visit a Participating Tommy Bahama Store and use your smartphone or other web-enabled device with data plan to scan the Sweepstakes quick response ("QR") code\* featured on signs in each Participating Tommy Bahama Store with the QR reader application already installed on your phone. You will be directed to a mobile web page associated with your Participating Tommy Bahama Store ("Website"). Or, to enter if you do not have a smartphone or web-enabled device, locate a salesperson at the applicable Participating Tommy Bahama Store and he/she/they will provide and assist you with a promotion tablet to scan the QR code. Then, follow the links and instructions to complete and submit the registration form with the information requested, including your first and last name, and email address. You will receive one (1) Sweepstakes entry into the Grand Prize Drawing and one (1) Sweepstakes entry into the applicable First Prize Drawing associated with your Participating Tommy Bahama Store.
  - b. Mail-in Alternate Method of Entry: To enter without visiting a Participating Tommy Bahama Store, hand print your name, address, day and evening phone numbers, email address, and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage and the name of your Participating Tommy Bahama Store written on the outside of the envelope to "Tommy Bahama Hawaii Sweepstakes," c/o Merkle Inc., P.O. Box 5964, Department 856302, Kalamazoo, MI 49003-5964. You will receive one (1) Sweepstakes entry into the Grand Prize Drawing and one (1) Sweepstakes entry into the applicable First Prize Drawing associated with your Participating Tommy Bahama Store. NOTE: If you do not include the Participating

Tommy Bahama Store you wish to enter written on the outside of the envelope, you will not receive one (1) First Prize Sweepstakes entry. Limit: One (1) entry per envelope. All mailin entries must be handwritten and must be postmarked by April 24, 2023 and received by May 1, 2023. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

c. Online Method of Entry (Grand Prize Drawing Only): During the Promotion Period, visit https://www.tommybahama.com/sweeps (also, "Website") and complete and submit the registration form with the information requested, including your first and last name, and email address. You will receive one (1) Sweepstakes entry into the Grand Prize Drawing.

\*To scan a QR code, participants must have a smartphone or other web-enabled device with a camera feature and QR scanner application and may incur message or data charges from their wireless service provider for each message sent and received.

<u>Limit</u>: You may enter one (1) time per day during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being an authorized account holder.

**Bonus Sweepstakes Opportunity:** Facebook Referral: After you register for the Sweepstakes or log in via the Website via 4(a) and 4(c), follow the links and instructions to share a message about the Sweepstakes on your Facebook wall. The post will contain a unique link to the Sweepstakes. If a friend subsequently enters the Promotion through the unique link, you will receive one (1) additional Sweepstakes entry into the Grand Prize Drawing. Limit: Up to ten (10) additional Sweepstakes entries, per email address/person, per day via this method during the Promotion Period.

5. Drawings: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Administrator will randomly select the potential Sweepstakes Grand Prize winner from all eligible entries received during the Promotion Period, on or around May 8, 2023. Administrator will randomly select each potential Sweepstakes First Prize winner from all eligible entries received for each Participating Tommy Bahama Store during the Promotion Period, on or around May 8, 2023. The potential winners will be notified by email. The potential Grand Prize winner (or parent/legal guardian if winner is a minor in his/her state of residence) will be required to sign and return a Declaration of Compliance, Liability Waiver (and subsequently will receive an IRS Form 1099 MISC) and where not prohibited a Publicity Release ("Declaration") which must be received by Administrator within five (5) days of the date notice or attempted notice is sent, in order to claim the prize. Potential First Prize winners may be required to provide their name, home mailing address (P.O. Boxes may not be permitted), and date of birth to confirm eligibility and for purposes of prize fulfillment within five (5) days of the date notice or attempted notice is sent, in order to claim his/her/their prize. If a potential winner of any prize cannot be contacted, fails to sign and return the Declaration or provide any other requested information within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner forfeits his/her/their prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason or forfeits the prize, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded.

Trip package includes round trip, first-class air transportation for two (2) from a major airport near winner's home (determined by Sponsor in its sole discretion, as well as first-class air transportation for two (2) for any applicable interisland flight(s)); six (6) nights' accommodations at hotels determined by Sponsor in its sole discretion (single room, double occupancy); three (3) dinners for two (2) at Tommy Bahama Restaurants (awarded as one (1) \$450 Tommy Bahama gift card, terms and conditions apply); three excursions of winner's choice from a provided list of options (subject to availability, allowance of up to \$700.00/excursion, winner will not receive difference between actual and maximum allowance); and \$1,000.00 spending money. TAX GROSS UP PAYMENT: Sponsor will also provide winner a single cash payment in the form of a corporate check, which is intended to assist the winner with any federal, state, or other tax obligations related to the Grand Prize (the "Tax Gross-Up Payment"). The Tax Gross-Up Payment will be \$11,828.57. The Grand Prize winner's actual tax liabilities related to the Grand Prize could exceed the Tax Gross-Up Payment. The Grand Prize winner is solely responsible for all applicable federal, state, or other tax obligations related to the Grand Prize. Sponsor will not provide any further assistance toward the winner's tax obligations. Winner must complete the trip within one (1) year from the drawing date or prize will be forfeited. Trip must be booked at least twentyone (21) days prior to departure. Travel and accommodations are subject to availability and blackout dates. Travel must be round trip. Sponsor will determine airline and flight itinerary in its sole discretion. No refund or compensation will be made in the event of the cancellation or delay of any flight. Travel is subject to the terms and conditions set forth in this Sweepstakes, and those set forth by the Sponsor's airline carrier of choice as detailed in the passenger ticket contract. All expenses and incidental travel costs not expressly stated in the package description above, including but not limited to, ground transportation, meals, incidentals, gratuities, passenger tariffs or duties, airline fees, surcharges, airport fees, service charges or facility charges, personal charges at lodging, security fees, taxes or other expenses are the responsibility solely of winner. Unless child of winner, travel companion must be eighteen (18) years of age or older as of the date of departure or a sibling/friend of winner with the appropriate parental permissions and releases and must travel on same itinerary and at the same time as the winner. If winner is a minor in his/her state of residence, travel companion must be winner's parent/legal quardian. Travel companion must execute liability/publicity releases prior to issuance of travel documents. Travel restrictions, conditions and limitations may apply. If in the judgment of Sponsor air travel is not required due to winner's proximity to prize location, ground transportation will be substituted for round trip air travel at Sponsor's sole discretion. Sponsor will not replace any lost, mutilated, or stolen tickets, travel vouchers or certificates. Sponsor is not responsible if any event is delayed, postponed or cancelled for any reason, in which event that portion of prize is forfeited in its entirety and no substitution will be provided except as in Sponsor's sole discretion. Approximate Retail Value ("ARV"): \$38,628.57. Actual value may vary based on airfare fluctuations and distance between departure and destination. Winner will not receive difference between actual and approximate retail value.

ONE HUNDRED (100) FIRST PRIZES (one (1) awarded for each Participating Tommy Bahama Store): Each winner will receive one (1) \$200 Tommy Bahama gift card, terms and conditions apply. ARV: \$200.00.

<u>For All Prizes</u>: Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winners are responsible for all taxes and fees associated with prize receipt and/or use. Odds of winning the Grand Prize depend on the number of eligible entries received during the Promotion Period. Odds of winning a First Prize depends on the number of eligible entries received for each Participating Tommy Bahama Store. Limit: one (1) Grand and one (1) First Prize per person. Total ARV of all prizes: \$58,628.57.

**7. Release:** By receipt of any prize, winners agree to release and hold harmless Sponsor, Administrator, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or

cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any prize.

- **8. Publicity:** Except where prohibited, participation in the Sweepstakes constitutes each winner's consent to Sponsor's and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration.
- 9. General Conditions: Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, if any fraud, technical failures, human error, or any other factor impairs the integrity or proper functioning of the Sweepstakes, or any event or cause beyond Sponsor's control (e.g. events such as natural calamities, national emergencies, wide spread illnesses, declarations of war, acts of God, acts of terrorism) interferes with any aspect of the Sweepstakes, including but not limited to fulfillment of the prize(s), as determined by Sponsor in its sole discretion. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance and may modify the prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 10. Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes, if it is possible. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Michigan without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.
